Lobbying in Washington & Austin... Your Voice on Laws and Regulations TPCA Day at the Capitol

As a member, you can participate in the TPCA Day at the Capitol in Austin. NPMA hosts a similar event in Washington that is open to members. This is an opportunity to join with other TPCA members in Austin and talk to legislators and staff about issues and bills that can affect your livelihood. Participants are trained on the legislative process and issues by our lobbyist. TPCA provides position papers and packets and our lobbyist conducts a training session to prepare attendees for their visit to the Capitol.

State and Federal Lobbying

TPCA and NPMA retain lobbyists to assist us with legislative issues in Austin and Washington. Representation before the government is in the Bill of Rights and is one of the main reasons people join together to form an association. Our lobbyist represents us in Austin and in Washington.

Regulatory Monitoring – Texas Department of Agriculture (TDA) and Structural Pest Control Advisory Committee (SPCAC)

TPCA attends all SPCAC meetings and reports back to TPCA members what actions are being considered and what regulations have been passed. As a member, you will be kept informed and have the opportunity to have input on issues that impact the industry.
